





























ABUELAS DE PLAZA DE MAYO

We are an NGO established in 1977 and our objective is to restore the identity to the babies, girls and boys -today adults- who were stolen during the military-civilian dictatorship in Argentina (1976-1983). We also work to educate on the value of the right to identity, a fundamental human right for all boys and girls of the world.

The Armed Forces that perpetrated the genocide in Argentina consolidated a regime of terror that illegally detained, tortured and, finally, made disappear 30 thousand persons of all ages and social standing, among them, children, pregnant women who gave birth in captivity, and whose babies were appropriated and grew under a false identity.

Through these decades, the "Abuelas" built a diverse set of strategies that have received national and international recognition. In the legislative aspect, we promoted the incorporation of articles 7, 8 and 11 in the United Nations Convention for the Rights of the Children that establishes the right to identity for all the infants; we propelled genetic science in the discovery of the "index of grandparents compatibility"; we made contributions in the areas of psychology, education, universal justice and to the education on human rights.

Today, we keep working to transmit this legacy comprised of learning, growth, and collective knowledge, so that these crimes against humanity are never repeated in

HOW DO WE WORK?

Our technical teams work in different areas and in five chapters (City of Buenos Aires, Córdoba, Mar del Plata, Rosario and La Plata):

- we receive, guide, contain and accompany the persons who doubt about their biological origins or have problems related to the infringement of their rights;
- we offer psychological help
- we are plaintiffs in many trials of crimes against humanity
- we prepare and conduct cultural a c t i v i t i e s t o e n s u r e t h e transgenerational knowledge of the memory and human rights experience through cinema, theatre, music, festivals, and book presentations

- we enable the knowledge for educators, institutions, and different professional areas on human rights, in a general and the right to identity in particular.
- we offer chats in schools, clubs, labour organizations, public services, to give witness to the crimes of the last dictatorship.

In Numbers

WORLDWIDE RECOGNITION GIVEN TO OUR WORK

Through the years our work has been acknowledged though many awards such as the Félix Houphouë-Boigny Peace Prize, UNESCO; "National Order of the Legion of Honour" Government of France, Order of Merit in the rank of Commander of the Italian Republic; the United Nations Prize in the Field of Human Rights, 2003; as well as recognition from, states, provinces and municipalities.

We also received many nominations to the Nobel Peace Prize, and 14 PhD Honoris Causa and honorary titles from all over the world, among them those granted by the University of Buenos Aires, Massachusetts University, the New School University of New York, the Autonomous University of Barcelona and the Medal of the Ville de Paris.

Presidents, lawmakers, mayors, ambassadors and many foreign authorities, in their official visits, request a meeting with the "Comisión Directiva de Abuelas" and its working teams to nurture from the experience and knowledge amassed by the institution. In addition, we constantly receive invitations from foreign countries to share our knowledge and education. In this sense, we have participated in different occasions in international conferences such as the International Convention for the Protection of All Persons Against Forced Disappearance, in Paris and the

General Assembly of the United Nations in Geneva.

Civil society organizations such as Asociación Pro-Búqueda from El Salvador, Todos los Niños Robados son También Mis Niños, and Asociación Bebés Robados from Spain; Foundation for Human Rights of South Africa; and relatives from Ayotzinapa in México, visit us to strengthen their own searches, in the understanding that Abuelas is the referent in the way in which the organisms could demand that the State should act when human rights are infringed.

We work in joint action with other organizations and institutions related to memory such as the Anna Frank House in the Netherlands and Argentina; the Elisabeth Käsemann Foundation in Germany; Paris 8 in France; Roma 3 in Italy; Universidad del Claustro de Sor Juan, La Universidad Autónoma Metropolitana y la Universidad Iberoamericana en México; and the Universidad Rey Juan Carlos de Madrid-Vicálvaro in Spain.

Frequently we meet with musicians, writers, visual artists, Nobel Prize recipients, athletes, clergy, religious dignitaries, and personalities who are in solidarity with our cause.
